PERSONAL GUARANTEE

Applicant:

In consideration of DEAKINS POND WHOLESale NURSERY, a corporation hereinafter referred to as Deakins Pond, extending credit to:

Hereinafter referred to as Debtor, for goods that have been or may be sold to Debtor from time to time by Deakins Pond upon consideration of the present forbearance by Deakins Pond on any existing indebtedness (which forbearance Deakins Pond can terminate at any time by notice to Debtor) and of the continued extension of credit to debtor, we jointly and severally agree as follows:

Upon demand we will immediately pay to Deakins Pond or assigns any sum due by Debtor to Deakins Pond and unpaid after the due date thereof.

It is understood that Deakins Pond may, without consulting or notifying us:

- * Extend the due date of any indebtedness, or any part thereof owed to it by Debtor.
- * Accept any promissory note or other evidence of indebtedness from Debtor, and renew or extend any such note or other evidence of indebtedness.
- * Accept collateral in any form, for any such indebtedness.
- * Assign this guarantee in whole or in part in conjunction with the sale, assignment or transfer, in whole or in part, of the indebtedness herein guaranteed, in which event the assignee, transferee or holder of the indebtedness shall have the right to enforce this guarantee, by suit or otherwise for his/her benefit as fully as if this guarantee specifically names such assignee, transferee or holder, but Deakins Pond shall have an unimpaired right to enforce this guarantee for its benefit as to any part of the Indebtedness herein guaranteed which it does not sell, assign or transfer.

Any such action on the part of Deakins Pond shall not relieve us of our obligation under this guarantee.

It is further understood that we shall become liable to Deakins Pond and that Deakins Pond shall not be obligated to notify us that it has accepted this guarantee. We also waive presentment, protest and notice of non-payment of any note or other evidence Of indebtedness accepted by Deakins Pond from Debtor. We reserve the right to terminate this agreement sixty days (60) after our communication of written notice of our intention to do so to Deakins Pond and any assigned of any indebtedness Covered by this agreement of which we have notice. Sixty (60) days after such communication the total of our liability shall be limited to the amount of Debtor's indebtedness to Deakins Pond at the time of the expiration of such period.
